## **SECONDARY SCHOOL-AGE NASAL FLU VACCINATION**

Kernow Health is delivering the immunisation programme on behalf of NHS England. In 2022/23 **secondary school-age children in years 7, 8 and 9** will be eligible for the nasal flu vaccine. The vaccination is free and recommended for children; it is administered by a quick and simple spray of mist up the nose. Please click on the link or enter [www.nhs.uk/child-flu](http://www.nhs.uk/child-flu) to access information explaining the vaccination programme which also includes details about the small number of children for whom the nasal vaccine is not appropriate. Flu can be a very unpleasant illness and sometimes causes serious complications. Vaccinating your child will also help protect more vulnerable friends and family by preventing the spread of flu.

Please submit your consent **by midday on Friday 9<sup>th</sup> December 2022** to ensure your child receives their vaccination. If you experience any problems accessing the form please **telephone 01872 221105** and the team will be happy to help. Please note that as in previous years **you must opt in** to the programme. If a consent form is not submitted your child might not be vaccinated.

- **Important: Your child can self-consent to treatment if they are considered competent to do so by one of our nurses; this is known as Gillick competency.
